Introduction

With the continuous development of technology and communication tools, it is very important to focus on the protection of the individual's privacy. For that reason we are committed to respect confidentiality during the collection of personal information.

The collection of personal information

We collect the following information:

- Name
- Company
- City
- Country
- Email Address
- Mobile
- Activity
- Postal Address

The personal information is collected through forms and the interaction between you and our website.

Forms and interaction:

In case of interaction between you and our website, we collect your personal information via the following forms:

We use this information for the following purposes:

- Correspondence only



Log files

We gather certain information by means of log files. The information we collect from analytics, you can learn more about [Google Analytics](#).

All of that information is anonymous – so we don't know who you are; just that *somebody* visited our site. It mainly concerns the following information:

- IP address
- Operating System
- Visited pages and made requests
- Connection date and hour
- Location of the visitor

The usage of above-mentioned log files allows us to:

- Improve our online personal reception
- Collect statistical information

Facebook, Twitter and other social networks

These services provide social buttons and similar features which we use on our website – such as the “Like” and “Tweet” buttons.

To do so we embed code that they provide and we do not control ourselves. To function their buttons generally know if you're logged in; for example Facebook use this to say “x of your friends like this”. We do not have any access to that information, nor can we control how those networks use it.

Social networks therefore *could* know that you're viewing this website, if you use their services (that isn't to say they do, but their policies may change). As our website is remarkably inoffensive we imagine this is not a concern for most users.



The right of opposition and revocation

We commit ourselves to offer a right of opposition and revocation concerning your personal information. The right of opposition is defined as the possibility, given to the visitors, to refuse the usage of personal information for certain purposes.

The right of revocation is defined as the possibility, given to the visitors, to request that their information is not recorded. For example, in a mailing list.
